In that respect, we inform you that the Bank acquired 1,036,300 common, book entry, Class B shares with a par value of Ps\$. 1 (one Peso) each and entitled to 1 (one) vote per share, with an average weighted price of Ps\$. 146.771 per share, and an aggregate amount of Ps\$. 152,099,283.25
